






Top View

Top View Pin-Out








VCE - Collector Emitter Voltage (V) **Safe Operating Area**






Pulse Power Dissipation

Max Power Dissipation (W)














VCE(sat) v IC




VCE(sat) v IC

VBE(sat) - (Volts)




